#### 1. Welcome and Apologies

Apologies from Cllr Ronnie Proctor, David Robinson

2. Minutes of the meeting of 31<sup>st</sup> May 2018 were approved.

3. Matters Arising from previous meeting

**Broadband** – David Short has confirmed that work is ongoing to connect Kilry area but no definite timing. Angus, Ronnie and Roger in touch with David.

AMD informed the meeting that 3 contractors dealing with Angus Council and David Short is one of them. Availability of funds and workload causing delay. SG's R100 scheme to reach every home and business in Scotland by 2021 gives no indication of how this will be achieved and a wireless solution is considered the best technology for Angus.

#### Phone Box Defibrillator

MM indicated that there was no evidence of work on the defibrillator at Folda.

#### Defibrillator

HH indicated that there is progress towards installing one at the village hall in Westmuir. And a committee had been set up to fund raise.

Discussion about types, training and importance of notifying SAS of installations. Proposal for CC funds (£1000.00) towards purchase of defibrillator at Isla School was approved after discussion.

PC Beattie reported a case of telephone fraud. MM reported unruly behaviour and vandalism at the Glenisla carpark/toilet area. Rural crime down since last year.

The application has been successful and the SCIO will receive community benefit money from Tullymurdoch Wind Farm 12 months after commissioning which is due in September 2018.

HH reported:

- a) problems in Westmuir with loss of water supply. Unfortunately this is not confined to Westmuir and the problem is a result of old and poorly maintained infrastructure. Residents should contact Scottish Water.
- b) Continuing concerns about the private airstrip near Auchendorie with records being kept by local residents. This information has now gone to Angus Council as the number of landings appears to exceed what is allowed under 'private' arrangements.

GH questioned the point of the bi-annual meeting on 19<sup>th</sup> September 2018 with CC elections imminent. AMD thought that this has been postponed but new date unknown.
